ETF Impact Investment Offerings

NPT offers exchange-traded funds (ETFs) that address a range of social and environmental issue areas. Some actively consider environmental and social factors in their selection of stocks (SHE, CRBN, MPCT), while others positively weight companies that perform well on Environmental, Social, and Governance (ESG) factors (SUSA, ESGD, DSI).

NPT also offers four impact notes, which allow donors to select from a range of maturity dates, minimum dollar thresholds and themes. For example, donors can invest in a 3-month note that focuses on food and agriculture, or a 2-year note that focuses on affordable housing. - Donors with a donor-advised fund account balance above \$500,000 may recommend alternative investments, subject to NPT's review and approval.
